Member of the public asked if the Silver birch could to be pruned. Parish Council agreed and would bear the cost.

Member of the public asked if the Parish Council could write a letter to the owner of the tall Leylandii trees across the other side of the river behind Hibberds Field. They desperately need cutting back, the member of the public feared that they may come down in high winds and be dangerous to users of the footpath. Members agreed that a letter to be written to the owners asking if they could cut them back.

Yellow lines in Cranborne – Wimborne Street cars permanently parked – discussion on parking. The Chairman advised that a parking survey had been completed a few years ago and the residents did not want yellow lines in the village. Unfortunately, it is not Parish Council's responsibility.
